Step 1: WV CARES (fingerprinting process)

Step One - Is the Fingerprinting process. The provider and all adult household members/residents eighteen years of age and older will need to be fingerprinted.

WV CARES is the vendor that has been approved by WV DHHR to process certain background checks. An Administrative Account can be set up by calling 1-304-558-2018 or email at <a href="www.gov">www.gov</a>

The provider will need to complete the WV CARES online Training.

The provider will then need to schedule an appointment to be fingerprinted at a Morpho Trust site.

## Step 4: Pre-Service Training

To get started, visit the WV STARS website (WVSTARS.org) to register for the Pre-Service Training.

Once you are notified that you are registered, complete the Pre-Service Training on the website. Upon completion of the course(s), print and keep certificates from transcripts for your records.





- 1. Go to WVSTARS.org
- 2. Click on Professionals- Green Box to the left
  - a. Access Registry Applications
- 3. Click on Join- Green Box to the left
  - a. Apply for a career pathway certificate or **Registry Online**
- 4. Click on Registry Participant- brings up how to apply for a WVSTARS Registry Profile Account online.
- 5. Click on Apply Online Now Click on the arrow and choose WVSTARS REGISTRY APPLICATION
  - a. Complete the application information tab and select "NEXT"
  - b. Read and Mark Agree to the Participant Agreement and select "NEXT"
  - c. Complete the employment information tab- <u>be sure to click on Occupation and select</u>

    <u>Early Care and is currently working as Early Care. The second tab also must be</u>

    <u>clicked, select Family Child Care Provider, both must have a selection.</u>
  - d. Complete the Demographic Information tab and select "NEXT"
  - e. Complete the "NEXT STEPS" tab by choosing WVSTARS registry application and select "REGISTER"
