

#### STARS Provides Professional Benefits

The West Virginia State Training and Registry System (STARS) is a comprehensive system that supports professional development experiences for all those working to provide quality early care and education opportunities to our state's children. STARS is available to all early care and education professionals working in a variety of settings child care centers, private and public preschools, Head Start programs, family child care homes and facilities, early intervention programs, schoolage child care programs, parent education opportunities, regulatory agencies, and trainers.

One main component of STARS is the Career Pathway. This pathway identifies eight levels of qualifications, credentials, and degrees. When a person registers with STARS, he or she will be recognized at a level based on educational preparation and experience requirements. The pathway is designed to be inclusive of all abilities, from those just beginning in the field to those with more advanced experiences. Career Pathway applies to all early care and education professional roles: teachers, assistant teachers, aides, directors, administrators, and agency personnel.

Once credentialed, the person's professional information will be entered into a database registry. In order to maintain an accurate and valid registry, it is necessary for everyone to renew the credentialing certificate every 3 years. To remain on the career pathway,

each person must complete 45 hours of professional development within the three years. By doing so the person continues their education and professional growth. Moving up the career pathway requires advancement in educational level and/or work experience.

Another main component of STARS is a trainer approval and registered training system. This system ensures that trainers are qualified to provide training in early care and education content areas. Trainers use the West Virginia Core Knowledge and Core Competencies to register trainings with specific content area(s), learning outcomes, and descriptions. Participants attend or provide these STARS approved trainings in order to meet the required 45 hours of training for renewal.

Because the registry database provides the state with a data source of all early care and education practitioners, certified trainers and registered trainings, there are many benefits to registering with STARS. Through STARS practitioners receive recognition for their professional preparation and experience. It is a tangible and visual recognition of one's accomplishments. This leads to a professional image to parents and the community. In addition, the career pathway can be used to market professional qualifications and to set career qoals.

There are also benefits of STARS to program administrators. The career pathway can assist in keeping an updated record of training, serve as a tool in working with parents and/or governing boards in setting rates, establish wage scales, help in hiring, and facilitate planning for staff development. This data source is a valuable tool for planning, policymaking, and funding programs.

Thousands in the state have already recognized the benefits of using the STARS Career Pathway. By doing so, the early care and education workforce enhances their skills and career opportunities. STARS participants are becoming better equipped to help the families and children of West Virginia succeed.

#### Carpooling on the "Starship Enterprise"?

Do you have a question? MountainHeart staff members are available to answer any question, simple to complex, which you may encounter during your journey as a self-employed child care provider.

Sometimes, you may feel shy or embarrassed to ask questions. However, Case Managers encourage you to call or come into the child care office to ask any questions you may have about your paper work. MountainHeart staff are more than willing to help you understand the correct way to complete your Request for Payment Forms. Submitting correct payment forms and attendance sheets will insure prompt payment. Paperwork that is returned to you, due to mistakes, will take more time to process and result in your payment being received late.

I would like to address an issue that is often encountered on provider's attendance sheets. Child care providers are often "cautious" when including travel time to and from a parent's job or school. However, travel time is allowed and to be expected. The provider will, many times, only list the parent's schedule, such as 9:00 a.m. to 5:00 p.m. on the attendance sheet. If a parent drops a child off to your care at 8:42 a.m. to be at work at 9:00 a.m., your attendance sheet

Only in the T.V. series Star Trek would a parent be able to drop off a child at 9:00 a.m. on the dot and then have Scottie "beam" them to work and be there on time. The same goes for picking a child up from care. If the parent leaves work at 5:00 p.m. and arrives to pick the child up at 5:23 p.m., your attendance sheet should reflect 5:23 p.m. The in and out times should always reflect accurate time.

Also, every child care provider, whether a family child care home, child care facility, or child care center, is required to have parents sign their full signature on the attendance sheets each day. Allowing parents to; (a) sign only initials, (b) sign the forms only once a month or (c) permit someone to sign for the parent, is not allowable.

If you are having any problems, or if you have questions concerning your Request for Payment Forms or Attendance Sheets, do not hesitate to contact your local MountainHeart office for assistance. Staff members are at your service to help you succeed as a child care provider and to provide the best possible care and service to child care families!

## Roma's Real World

Autism

Dear Child Care Providers,

I attended an Autism workshop in August that was sponsored by the Autism Training Center, Marshall University. I received a great amount of valuable information that may help many child care providers that have children with suspected Autism.



What is Autism? Autism is a generic term that includes several specific disorders. The official medical name for Autism is Pervasive Developmental Disorder (PDD). A child with Pervasive Developmental Disorder has a pattern of delayed or difficult language development and impaired social interaction when compared to a child without PDD. Children identified with PDD have a unique set of symptoms in three areas: communication, socialization, and repetitive behaviors.

When planning for children with Autism the following qoals and objectives should be addressed:

- ♥ daily living skills
- ♥ help children be independent
- help children understand self and feelings
- help children learn problem solving skills, and
- ♥ help children learn academic content.

When planning for children with Autism, care givers should think about having a back up plan, that includes learning how to manage the environment, setting rules and developing transition activities that meet the child's needs.

Please call Roma if you need some strategies or help setting up the environment and curriculum to met children's specific needs. staff, structured learning with an emphasis on fun, and lots of TLC. We treat all children as individuals and their families as unique." A Place To Grow also collaborates with the Fayette County Board of Education to provide a public school WV Pre-K program on site. "The success of our program is directly attributable to the dedication of our staff. It takes special people to be successful in the early education field and we have been very fortunate to maintain such a high quality teaching staff", says the director.

More than 11,000 early childhood programs serving over one million young children are currently accredited by NAEYC. "In recent years, we've seen a growing number of childcare and preschool programs earning NAEYC Accreditation," said Mark Ginsberg, Ph.D., executive director of NAEYC. "By earning accreditation, A Place To Grow Children's Center has become a leader in a national effort to raise the quality of early childhood education, and to help give all children a better start."

Responding to the growth of the system, in 1999 the NAEYC Governing Board appointed a National Commission of Accreditation Reinvention to conduct a comprehensive review of NAEYC's Accreditation system. Building on their work, NAEYC is making many changes to increase the reliability and accountability of the accreditation system and promote higher program quality. In April 2005, the NAEYC Governing Board Approved Early Childhood Program Standards and Accreditation Criteria, which will be used in the future to assess whether programs receive accreditation.

NAEYC created its accreditation program in 1985 to set professional standards for early childhood education, and to help families identify high-quality childcare and early education programs. To earn NAEYC's accreditation, a program conducts a self-study to determine how well it meets the standards. After necessary improvements are made, the program is observed by independent, professional validators, and then reviewed by a national panel. Programs are accredited by NAEYC for a five-year period.

Melissa Colagrosso admits, "It was a long and sometimes overwhelming process to apply and receive accreditation. I would, however recommend that all centers strive for accreditation. NAEYC accreditation has allowed our staff to receive the much deserved respect and recognition they deserve in this field. Accreditation also means a higher reimbursement rate from West Virginia Department of Health and Human Resources. The increased rate has allowed us to continue to serve subsidized families while increasing the quality of our early education environment and staff training. Melissa Colagrosso states, "A Place To Grow is proud to be one of less than fifty early education programs in our state, and one of only two in our area to receive this prestigious accreditation. We're proud to be recognized for our efforts to continually improve early education in Southern West Virginia. The children are our future and the future is looking brighter in Fayette County."

The Earned Income Tax Credit (EITC) is for working families with incomes less than \$37,263. If you are eliqible, you may receive money back from the Internal Revenue Service (IRS) even if you don't owe taxes - but you must file a tax return.

You may also qualify for the Child Tax Credit (CTC), a federal tax credit worth up to \$1,000 per child. You may qualify for the CTC if you have an earned income above \$10,500 and you can claim at least one dependent child under age 17.

Fire Safety

October 9th - 15th is fire safety week. Many organizations spend the whole month of October focusing on fire safety. What is the big fuss? According to

National Fire Prevention Organization, in 2005 there were 381,000 house fires. Those fires led to 3030 deaths, and 13,300 injuries. That means that every three hours someone in America dies from a house fire.

That does not even begin to take into account other kinds of fires.

Fire safety is important all year long, but it can be helpful to take time during the year to teach our children the importance of fire safety. Remember that all child care providers must have escape plans made and posted, smoke detectors on every level of the building, and fire drills at least once a month (twice a month in the case of centers). All of this work does no good if the children do not know what to do if a fire really happens. There is a lot to be taught. Children need to know about "Stop, drop, and roll", checking for hot doors in case of a fire (to see if there is fire on the other side), as well as how to get out of the building and where to meet.



There are lots of resources available to use for a fire safety unit or classes. The US Fire Administration has lots of good information. Their website also has a kids section. Their website is <a href="www.usfa.dhs.gov">www.usfa.dhs.gov</a>, and their phone number is 301-447-1000. The Nation Fire Prevention Association has lots of facts and information for people that are interested. They can be found at <a href="www.nfpa.com">www.nfpa.com</a> or 617-770-3000. #### Fire Safety Activities

Fire Drill: A great safety activity is to show the children the escape routes out of each room, and then to have your required fire drill. Let the children hear the fire alarm so they are not too scared to do something if it actually goes off (which also tests the batteries in the alarm at the same time). Then they practice getting out of the house and to safe meeting spot just like they would in a real fire.

Obstacle Course: When children are old enough, have them practice getting out of a building that is full of smoke. The easiest, and most fun way, is to set up a simple obstacle course and even blindfold older children. When they find the way out they could earn a treat. (Anything from a small prize to getting to eat lunch outside for the day would work great as a reward.) Remember that they should be crawling to avoid smoke (and injuries).

Field Trips: Lots of fire departments will give tours of the fire house or might even bring a fire truck to your child care site. If they will put on their fire gear, it could be a great experience for the children, as many children will run or hide from fire fighters in their gear out of fright. We want to make sure children know they are the good guys if trapped in a fire!

Stop, Drop, and Roll Game: Stop, Drop, and Roll is a hard thing for children to do, when the instinct is to run when you see that you are on fire. A great way to practice is to have the children run in a set area. When you shout "Fire" children should Stop, Drop, and Roll. Be sure to explain why this 'fun' is so important to practice!

Trainers as a rule rarely get to see the after-effects or the end results of what providers and children do with the resources, activities and information that have been presented in training. Much time is spent doing research for topics that are user-friendly, easy to work with and interesting. Knowing that all children do not tend to respond with the same level of excitement to the same projects and activities, it is of the utmost importance to provide an array of topics that are professional and promote best quality practices. That's why when given the opportunity to share news of a successful activity for children and providers, I jumped at the chance.

Debbie Bowyer attended a training this Summer in Raleigh County at the MountainHeart Community Services office on Ragland Road in Beckley. After showing up and signing in, Debbie made it known to me that she had some pictures of a cooking activity that she and her grandson had recently completed. The activity happened to be a recipe from "The Kids Book of Food, Fitness and Fun" that was given out by MountainHeart Community Services at this year's annual Provider Conference on Saturday, June 17 at Tamarack in Beckley. Debbie and her grandson Dakota, who is 11

years old, chose the recipe "Chocolate-Raspberry Trifle" on pages 84 and 85 of the Desserts Section in the Food, Fun and Fitness book. Debbie, a provider in Raleigh County who also works at the YMCA Happy Kids Preschool in Beckley said of the recipe

#### What To Do About The Flu

The flu is a problem that every child care provider is concerned about. A flu outbreak can severely affect your job as a provider. It can mean lack of help due to staff illness as well as a loss of customer due to sick children. Preventing the spread of influenza (the flu) in child care settings is vital.

Symptoms of flu include fever (usually high), headache, extreme tiredness, dry cough, sore throat, runny or stuffy nose, and muscle aches. Nausea, vomiting, and diarrhea also can occur, and are much more common among children than adults.

The main way that flu is spread is from person to person through coughs and sneezes. This can happen when droplets from the cough or sneeze of an infected person travel through the air and reach the mouth or nose of people nearby. Sometimes flu can be spread when a person touches droplets, nose drainage or saliva from an infected person, or a soiled object, and then touches one's own (or someone else's) nose or mouth before washing hands.

Vaccination against the flu each fall remains the primary way to prevent this disease. Vaccination, along with other measures, also may help to decrease the spread of influenza among children in the child care setting and among care providers.
