Changes to the Subsidy Program

Child care fees for parents earning between 40% and 150% of the Federal Poverty Level (FPL) will be increasing by approximately 50%. Please be sure to check the subsidy certificates that you receive for the amount of the parental co-pay, as some parents' fees will be increasing.

Effective January 1, 2013, families currently receiving services who earn over 150 percent of federal poverty level will no longer be eligible for child care once their current certificate expires.

Fire Safety

The National Fire Protection Association has declared October 7th thru the 13th as National Fire Safety Week

The time to turn our heat on is right around the corner, so it's perfect time to look at some fire safety facts.

Fire Alarms

- Smoke alarms are extremely effective at preventing fire related to death and injury. The chances of dying in a residential fire can be cut in half when a smoke alarm is present
- ♥ It is estimated that a \$44 smoke alarm generates \$770 in benefits to society
- ♥ When a child under 5 dies from a residential fire a smoke alarm is not working or not present in 2/3 of the occurrences
- ♥ 40% of house fire deaths occur in 4% of US homes without a working smoke alarm
- ▼ The end of daylight savings time is November 4th 2012. Remember to change the batteries in your fire alarms when you set your clocks back

Fire Extinguisher

- ▼ The fire extinguisher should not be blocked by furniture or anything that might limit access in an emergency.
- A fire extinguisher should not be accessible to children.
- ♥ Fire extinguishers should be inspected annually or more frequently if recommended by the manufactures instruction.
- Your first priority as a child care provider is to remove children from the vicinity of the fire, safely and quickly. Fighting a fire is secondary to the safe exit of children and staff.
- When caring for children under the age of 2, cribs intended for evacuation purposes should be of a design and have wheels that are suitable for carrying up to five non-ambulatory children less than 2years of age to a designated evacuation area. This crib should be easily movable and should be able to fit through the designated fire exit.

Head Lice Happens



According to WV Child Care Center Regulations children with head lice should be excluded. Section 14.4.e.4.F

So, as long as the child has an active case of head lice then they can be excluded from coming to the center until the lice is cleared up. In the case of children who seem to keep head lice all the time, then the center certainly has the right to prevent them from coming to the center unless the child can be shown to be free of lice or nits. Regulations do not say if you can or cannot expel them from the center permanently, but it is generally better to allow them to attend if the lice are gone. It is recommended in problem cases to make sure the child has a head check before they are allowed into the classroom in the morning and to do it in the presence of the parent.

If the child is in a county Pre-K or is school age then some counties have what is called a nit policy where the child can return to school with nits as long as there are no live lice present. So in this case it depends on the county school system and their policies.

Please keep in mind that lice may be a nuisance but they are not a health threat. They do not carry disease and they spread from direct contact. They do not fly and they do not jump, they crawl from one head to the next.

ROMA'S REAL WORLD

Back to School Anxiety



Each school year millions of parents and child care providers are confronted with children beginning the school year with anxiety. The fear that children have about school is very real; they may be apprehensive about separating from their parents, riding the school bus, or meeting a new teacher. The emotions your child experiences before school starts can also lead to a general sense of anxiety; a feeling that most children won't be able to articulate or understand.

It is important to remember that when placed in any new situation, all children are going to need to take time to adjust, figure out their comfort zone, and realize their requirements to fit into the new environment.

There are steps that you can take to prepare children both emotionally and physically so they can have the best start possible for the new school year:

Take away as many unknowns as possible. Show children what the school year will look like. Talk to children about what they are going to be doing in the new learning environment. Review where the classes will be, visit the child care center or pre-school setting, the playground, the library or the art

room. Talk about your own school days and emotions that you felt, and what made your school experiences special.

Who will I play with? Many children experience anxiety over how they will handle social situations in a new setting. Children worry about who they will eat lunch with or play with. Invite children over for a play group, pool time, or a walk in the park to build new relationships. Try some role play or read stories to ease their fears.

If your child's anxiety persist. Even if you do all the right things your young child or a child in your care may still has a bad case of the nerves or extreme anxiety. Many children report physical symptoms such as a stomach ache or head ache. Others will regress to earlier behaviors, including thumb sucking or wetting the bed, while some children act out aggressively, fighting with siblings or talking back to parents. Allow your children to talk about their fears, coach children in problem solving, and if anxiety persists talk with the teacher or the parents.

Going to school, pre-school, or child care causes a wide range of emotions and challenges for parents as well as children. Whether it is dread, excitement, fear, or euphoria, all these emotions can be bottled up inside our children. Remember that any one symptom of distress doesn't reinforce a child's fate or mean that their school year will be a failure. All children, at some point in their academic career, will struggle, so try hard not to view their setbacks or anxiety as a permanent threat to their school year. However, through encouragement, support, and keeping your finger on the pulse of your child's emotions will lay the groundwork for their future success in school.




Let's Move! Child Care



Here's an idea vou can use in your child care setting. If you happen to have a child that might be going to the dentist, read the book "Going to the Dentist" by Anne Civardi or check with your local library on this subject.



Add to your dramatic play area the following items: appointment book, bowls, calendar/notepad, paper bibs, paper cups, posters of teeth, small flashlight, and a white shirt for the child being the dentist. You can talk to the children about these items and discuss how they would be used in a dentist office. By having real items will help encourage dramatic play.

Snow Mosaic

Materials:

- Birdseed (such as sunflower seeds and cracked corn)
- Fruits and vegetables (like apples, kale and carrots)
- Food coloring
- Pump bottles

Instructions:

- Start by prepping your art materials; fill the pump bottles with different hues of food-color-tinted water and cut up various fruits and vegetables. Then take the materials
- Next, start your masterpiece by lying back in the snow to make a body print. Gently rock your body to pack the print, then carefully get up (you may need a friend's help).
- Create a portrait by filling in the shape with the seeds and vegetable pieces and adding details with the colored water.

Tips:

Younger kids may find it easier to work with fewer materials and to use cups or small pitchers (instead of their hands) to pour lines of seed. Remember to have the artists sign their initials somewhere, too!

I have a parent who suggested that I use candy as a reward to help her child learn acceptable behavior in our child care center. What are your thoughts on this type of strategy?

Dear Sugar Free Sara,

Candy or This is not an acceptable strategy. food should "never" be used as a reward to encourage acceptable behavior or as punishment. You should teach children what your expectations are for the child care center and encourage them to meet those expectations without being taught they will receive tangible rewards such as candy. Giving candy as a reward for every activity or for good behavior is also providing a child with loads of sugar and empty nutritional value!

If you feel that a token system is needed to help a child learn self-monitoring skills then use "special time". Set aside a time in the afternoon to do a special game or just spend time doing positive guidance. There are many strategies that can be used to encourage acceptable behavior. Please call me for more guidance.

Salt Dough Leaf Prints

Materials Required:

- ▼ salt dough
- artificial silk leaves
- ♥ round container to use as cutter
- Oven
- ▼ acrylic paint
- ♥ mod podge for sealer

Salt Dough Recipe

- ▼ 4 cups flour
- ▼ 1 cup salt
- ▼ 11/2 2 cups
 water
- extra flour for kneading

Mix first 3 ingredients together to form a nice soft



dough. Knead smooth with extra flour. The more you knead this dough the easier it is to work with. Keep leftover dough in the fridge. This recipe will make enough for 8 rounds. Roll out dough and the using circular container or bowl; (coffee can) cut your rounds. Pick a leaf for your design. The silk leaves leave a better impression in the salt dough. Place where you want it and press the leaf into the dough. When you lift it off you should have a nice impression. Place on a parchment or foil covered cookie sheet and bake at 250 degrees for about 2 - 3 hours or until hard. Let cool. Take some acrylic paint in autumn colors. The best way to paint these is to paint the leaves in different colors first. Let dry. Then using dark brown paint that you have watered down apply a wash, like an antiquing glaze to the entire surface. The dark color picks up the veining in the leaf and still lets the autumn color show thru. Let dry and then apply a coat of glossy Mod Podge as a sealer.

Mini Sweet Potato Pies

Ingredients

- ▼ 3/4 pound sweet potato, peeled and diced
- ▼ 1 (9 inch) refrigerated
- **♥** 3/4 cup evaporated skim milk
- ▼ 2 egg whites
- ♥ 1/4 cup granulated sugar
- ♥ 2 tablespoons brown sugar
- ♥ 3/4 teaspoon ground cinnamon
- ▼ 1/8 teaspoon ground nutmeg
- ▼ 1/8 teaspoon ground cloves
- ▼ 1/4 cup halved cranberries (optional)

Cooking Instructions:

Place the sweet potato in a saucepan with just enough water to cover. Bring to a boil, and cook until fork tender, about 5 minutes. Drain and mash with a fork or potato masher. Preheat the oven to 425 degrees F. Divide the pie crust into 24 small balls. Press them into the cups of two 12 cup mini muffin pans to make tartlet shells. Set aside. Spoon the sweet potato into a blender or

food processor, and add the evaporated milk, egg whites, white sugar, brown sugar, cinnamon, and cloves. nutmeg, Puree until smooth. Spoon about tablespoon of this mixture into each tart shell. Bake for minutes in the preheated oven, or until a toothpick



inserted into one of the tarts comes out clean. Cool in the pans over a wire rack. Garnish each tart with a cranberry half before serving.
