What is Education? By: Larry Kincaid, Director, Mountain Heart North

What is education? This may sound like a ridiculous question for anyone to ask, but think about it for a minute. Most of us would think first of going to school and getting a formal education. And by doing so, we would receive an official piece of paper that proves we have been educated.

Webster's Dictionary defines educate as "to develop the mind, knowledge or skill." This would mean of course that anything we do that develops the mind or teaches a skill to a child could, by definition, be called education. Thus comes the hardest part for most of us as adults; to accept the way we are educating young children. We often say and do things that the child will then repeat. Then we say, "I wonder where that came from," when they imitate what they have seen us do.

Language is the first point I would like to address. Recently, while hanging a picture I hit my finger with the hammer. Without thinking, I said "% ^\$# that hurts." Of course my three-

year-old granddaughter, who was watching me, now says, "%\\$#" to just about any negative situation. Why would she pick up on that one word the first time she heard me say it? I believe it has to do with my distress over the pain in my finger that allowed

her to make a mental connection with the word and displeasure. So now anytime she is unhappy she says, "% ^\$#." I hope this will not be my only lasting contribution to her language development to which I can lay claim.

The second point I'd like to address is modeling appropriate behaviors. The process I'm speaking about is how we, as adults, and to a large degree other children, model behavior (GOOD or BAD) for all children. It would seem to most of us that our children often pick up the negative behavior much easier than the posi-

tive behavior that we want them to display. On this point I think it's just

more fun some of the time to engage in the negative behavior than the positive. Not sharing is a good example of this thought. Why share when I can have it all? How do we change this thinking? Certainly not by saying %^\$# you have to

share with other kids. We do this by pointing out the unfairness of the behavior and not allowing it to continue and by always being consistent with our actions with all the children we care for.

Keep in mind that every time you come into contact with a child you have an opportunity to educate that child. The challenge is giving them something that advances the development of their mind and skills without inadvertently teaching unacceptable behavior they might distribute among their peers.

TRAILS Tip By Janet Aitchison

Summer has slipped by and fall is right around the corner. What a wonderful time to look at your child care space with a questioning eye. What has been working and what is not? Perhaps it is time to consider a few changes. Take the toys out of the toy box! What message are we sending to children when we throw their toys in a box? Toy boxes are not a good way to

teach respect for belongings. Put those toys on the bookcases so



choosing a toy is not overwhelming. Label the space with a picture of the toy so putting toys

away is a matching game. Put the books in a crate, "file" style, so children can make a selection by looking at the book cover.

Do you rotate your toys? Too many choices can be overwhelming. Put some of your toys away for a month and then when you bring them out, they will seem new. Consider rotating your toys on a regular basis.

Remember, children and adults function better in an organized environment.

Medication Administration Training By Willetta Bolinger

Medication Administration training is currently being offered throughout our 15 county region. As per center licensing requirements, staff members who work in child care centers or Head Start and who administer medication must have specific training.

In order to provide the appropriate skills and knowledge to staff members who will be administering medication, the West Virginia Department of Health and Human Services, Early Care and Education Division, has designed a specific training to meet this requirement.

Within our region, Lori Merrill, RN, and Sarah Hicks, RN, are providing the training on a monthly basis. The training consists of lecture, discussion, hands on activities and concludes with skills testing. All participants must pass the competency test with 80% accuracy to receive credit for the training and be allowed to administer medication

A training schedule is sent out quarterly to all child care center & Head Start directors. Registration is required for the training as a limited number of slots are available. (We must also have a minimum number of participants before we can have the trainings.) Participants must be STARS registered before attending the training.

Currently, child care staff members are allowed to have "interim" medication administration training that meets certain guidelines and is taught by an approved health care profes-However, Mountainsional. Heart and the WV DHHR Early Care and Education office encourage Head Start and child care staff to attend the approved training that is being provided by Ms. Merrill and Ms. Hicks within our region. In the near future, all medication administration trainings will have to be obtained through Registered Nurses who have been trained and approved by the WV DHHR Early Care and Education office (as Ms Merrill and Ms. Hicks have been). Although a deadline determining when the interim training will expire has not been determined, we encourage

directors to send staff to the WV DHHR ECE approved Medication Administration training before it becomes mandated.

We have received many complimentary comments concerning the Medication Administration training that is being offered by Ms. Hicks and Ms. Merrill. Participants have commented on how much they have learned in the training, how the hands-on practice have made them feel more comfortable administering medication and how knowledgeable and helpful the Registered Nurse trainers were in their training sessions.

TRAINING REMINDER

You are encouraged to submit your WV STARS Career Pathway application to the WV STARS office at least 4-6 weeks in advance of the training session. West Virginia State Training & Registry System (STARS)

West Virginia STARS is a comprehensive system of professional development, credentialing, and career mobility in early care and The Career Pathway education. encourages higher levels of skills, as illustrated in the three tiers of the core competency areas. knowledge and core competencies are the foundation for a professional development system. They provide a blueprint for individual professional growth, and also serve as guidelines for training and education programs that will meet the needs of professionals in the field.

The mission of STARS is to improve the quality of care and education for young children and their families in West Virginia by enhancing the skills and career opportunities for all those who care for and educate young children.

West Virginia STARS is available to all early care and education practitioners working in a variety of settings. This includes child care centers, private and public preschools, Head Start facilities, early intervention programs, school-age child care programs, parent education opportunities, regulatory agencies and trainings.

When you enroll in STARS, you can expect to receive a consistent base of training in the core competencies for early care and education


professionals. You will receive formal recognition for your level of accomplishment on the career pathway through an organized tracking system.


Jenny Drake, Case Manager

The Little Fur Family are favorites. Gather a small child and several Margaret Wise Brown's books onto your lap and enjoy.
