## Implementation of New Training Plan

MountainHeart, with input from the Training Advisory Council, has developed the Region V training plan for the 2005-06 year. The plan has been submitted to the Early Care and Education office for approval.

Several strategies from last year's training plan proved to be successful in raising the attendance at training sessions. The Training Advisory Council decided to continue these strategies, as well as implementing a few new ones. Strategies that proved to be successful included having child care providers and educators call the MountainHeart office to register for training sessions and providing training in centrally located sites. A new recommendation that will be implemented as of July 1, 2005 will be that a minimum of five participants must be registered before a training session will be held. It was also decided that participants must complete the entire training session in order to receive a certificate of attendance. Certificates will not be issued for a portion of the training session (example: 1 hour of a 2 hour training).

The 2005-06 training plan calls for a new strategy in providing the annual Child Care Providers' Conference. Due to the large geographic area of Region V, it was decided that a one day conference will be held in the eastern portion of the region and a one day conference will be held in the western portion of the region.

A new set of training modules has been developed by a work group consisting of professionals in the early childhood field. The *Components of Quality Care and Education* modules will be implemented by all Child Care Resource and Referral agencies in West Virginia during the 2005-06 year.

More information regarding the 2005-06 training plan will be distributed to child care providers and educators in Region V in the near future.



## Birth-To-Three

The West Virginia Birth to Three team would like to remind parents and childcare providers that the RAU 5 Birth to Three Program serves families within Barbour, Lewis, Preston, Randolph, Taylor, Tucker, and Upshur counties. West Virginia Birth to Three is a program designed to provide assistance and support to children from birth to age three who may be at risk of having a developmental delay. West Virginia Birth to Three services are provided at no cost to families, services are provided in the child's home, and anyone can make a referral to the program.

The West Virginia Birth to Three system targets children with developmental delays and children under the age of three who are at risk for or may have substantial delays in areas of child development. The West Virginia Birth to Three system can also help enhance the functional ability of eligible children across all developmental domains and increase the capacity of families to better promote their child's development.

The eligibility requirements for a child to be in the West Virginia Birth to Three Program are 1.) The child must be under the age of three years, 2.) Have a substantial delay or atypical development in one or more areas of development, 3.) Have a physical or medical condition that has a high probability of resulting in a developmental delay, or 4.) Have the presence of four of the twenty risk factors identified in state policy.

## Child Care Policy Changes

The State of West Virginia has revised the WV Child Care Policy Manual, effective May 1, 2005. The policy has been revised in order to make parts of the policy easier to understand and to add to the policy as needed.

The Child Care Policy Manual has been extended from 14 chapters to 18 chapters. This Policy is used by the Resource and Referral Agencies as well as the Department of Health and Human Services. Parents who qualify for assistance with child care costs are meeting requirements outlined in this policy manual. Resource and Referral Case Managers use this manual to base case decisions. This policy also explains the provider involvement with the subsidy program participants.

The policy was revised to clarify issues that required more details. One part that has been clarified is the additional charges that child care providers may require of child care participants.

The policy now states "2.2.6 Explanation of the payment rates available through the program and an explanation of allowable charges by the provider ( See chapter 6.3.2 Certificate Payment Rates Sectional and Appendix B: Child Care Payment Rates) Allowable charges by the provider shall be limited to: reasonable registration fees, late fees, and charges for the time not approved by the agency. The provider shall inform the parents if these fees prior to enrollment. If the parent is responsible for paying a portion of the daily fee, the daily fee shall only be charged for the days that the child is actually in care."

Another addition to the policy states "5.2.4.7 Providers shall not bill the daily fees for days that the child is not in care."

Chapter 6 explains the purchase of Child Care through certificates. This chapter explains the different types of child care providers and the use of child care providers through the certificate (subsidy) program. The payment form process is also explained in this chapter, the same as it is explained to providers at the time of enrollment. The sign in and out forms are to be accurately completed and signed by the child care providers. The provider may be charged with negative actions if the sign in and out sheets are not correct. The policy now states "6.5.2.3 . . . If there is substantial misrepresentation by the provider, the provider shall be prohibited from future participation in the Certificate Program. However, if the provider makes full restitution, a one time waiver may be considered. The provider must request the waiver in writing, and the R & R worker shall forward the request to the Division of Early Care and Education for approval/denial."

These changes were put into effect beginning May 1, 2005. Along with the policy the State also created forms for the subsidy clients to use for reporting information to their case managers. Client changes will need to be reported on these forms, which are available from all MountainHeart offices.

If you are a subsidized provider, you will notice that MountainHeart North case managers have been adding additional information on child care certificates in order to show the parents' approved hours and days. The case managers are determining the number of hours and days based on the information that has been provided by the parent. If the parent begins using child care on a different schedule than what is shown, it is possible that the parent has not reported a change. The <u>parent</u> is the person responsible for reporting changes to the case manager.

The information discussed here are the areas in which MountainHeart receives the most questions about. #### 10 Reasons to Keep Kids Off Soda

- 1. Soda contains no nutrients, and is high in calories and sugar. Studies show a strong link between soda consumption and childhood obesity.
- 2. Soda suppresses the appetite so kids are less likely to eat nourishing foods. Soda drinkers are less likely to get the recommended levels of vitamin A, calcium, and magnesium.
- 3. Phosphorus, a common ingredient in soda, can deplete bones of calcium. Girls who drink more soda are more prone to broken bones. Doctors are becoming concerned about the health impact of carbonated beverage consumption on teenage girls.
- 4. Studies show a direct link between tooth decay and soda. Not only does the sugar cause cavities, the acids in soda etch off tooth enamel. Acid can begin to dissolve tooth enamel in only 20 minutes. Dentists are reporting complete loss of the enamel on the front teeth in teenage boys and girls who habitually drink sodas.
- 5. Caffeine is known to create physical dependence and upsets the normal balance of neurochemistry in the developing brains of children. Caffeine stimulates the adrenal gland without providing the nourishment it needs. In large amounts, caffeine can lead to adrenal exhaustion, especially in children. Colas contain 35 to 38 milligrams of caffeine per 12-ounce can. Diet colas often contain a lot more. A can of Pepsi One has about 56 milligrams of caffeine. Mountain Dew, Mello Yellow, Sun Drop, Jolt, Barq's Root Beer, and Sunkist Orange soda all contain caffeine. Sprite, 7-Up, ginger ale, and many brands of root beer are caffeine-free.
- 6. Drinking a lot of soda every day can lead to blood sugar disorders, including diabetes.
- 7. Aspartame, used in diet sodas, is a potent brain toxin and endocrine disrupter.
- 8. Citric acid, often found in soda, may contain traces of MSG. MSG is another potent brain toxin. The artificial flavors found in soda may also contain traces of MSG.
- 9. Drinking sodas regularly can upset the fragile, acid-alkaline balance of the stomach, creating a continuous acid environment. This prolonged acid environment can lead to inflammation of the stomach and duodenal lining, which can be quite painful.
- 10. Sodas act as dehydrating diuretics, much like tea, coffee and alcohol, and can inhibit proper digestive function.
